4) Online Workshops (developed and maintained by the national teams of the Online Platform partner Houses). Each workshop addresses a topic, which is deemed to be an area of expertise for a particular country/national team:

- Individual complaint to the UN Human Rights Committee: admissibility, argumentation, implementation (developed by the national team of Belarus);
- Cooperation between lawyers and journalists/media (developed by the national team of Russia) – suspended;
- The right to property in the context of alienation of real estate for the state needs (developed by the national team of Azerbaijan) – suspended;
- European Court of Human Rights: argumentation and implementation of the decisions (developed by the national team of Ukraine).
- Torture and Issues of Impunity: experience of Moldova (developed by the national team of Moldova) – suspended, workshop materials need to be updated;
- Role of lawyers in development of case law and human rights standards
- Convention on the Elimination of All Forms of Discrimination against Women: contemporary forms of discrimination, individual complaint to the UN CEDAW Committee, Convention implementation (developed by the national team of Belarus);
- Human Rights Lawyers at Risk – developed jointly by the ILIA national experts, alumni and managers during the solidarity and advocacy campaigns in support of human rights lawyers. In accordance with the partners’ common decision, the online platform is now used to systematize and archive the most important materials, so that to develop the ILIA institutional memory, while urgent and current actions are discussed in the *ILIA International Club* Google group. The national team of Moldova moderates the group as part of the additional responsibilities taken on to support human rights lawyers at risk.

5) Legal Consultation on Human Rights Defenders

The page is updated with information related to the cases of HRDs and the special tools and arguments applicable in court trials at the national and international levels, including Ales Bilaiatski’s case file and *amicus curie* sent to the European Court of Human Rights.
